In St. Vincent and the Grenadines, Limited Liability Companies (LLCs) are established to engage in lawful business activities. To form an LLC, the application process involves liaising with a licensed Registered Agent within the country. An LLC operates under an Operating Agreement, which outlines the roles and interests of managers and members.

Does St Vincent and the Grenadines need a list of shareholders?

There is no need under St. Vincent and the Grenadines law to submit a list of shareholders and the beneficial owners of shares are also fully protected by the Preservation of Confidential Relationships (International Finance) Act 1996, with their details always remaining private.

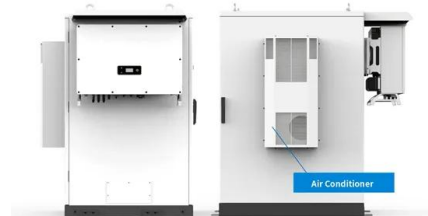
